ACKNOWLEDGEMENT OF RISK

FIELD WORK TERM AT BENNINGTON COLLEGE

I acknowledge that engaging in a domestic Field Work Term experience or undertaking international travel for study or work outside the United States carries inherent risks that may differ from those encountered while residing and studying on the Bennington College campus. These risks encompass, but are not restricted to, potential occurrences such as illness, injuries extending to the extent of fatality, mental health challenges, emotional distress, or damage to personal property. These risks may arise from various circumstances or activities, including, but not limited to, the items listed below.

FOR DOMESTIC AND INTERNATIONAL FIELD WORK TERM SITE EXPERIENCES:

- different levels of supervision, safety, or security;
- different physical surroundings, terrain, and weather conditions;
- different expectations with respect to conduct and performance;
- different social norms, including standards of dress and appearance;
- different laws and standards of law enforcement, including with respect to drug and alcohol laws.

FOR FIELD WORK TERM EXPERIENCES WHILE LIVING ABROAD:

- travel, vehicles, airplanes, boats, and other forms of transportation; and different:
- political, legal and social systems;
- economic conditions;
- laws and law enforcement means and methods;
- standards of design, accessibility, safety and maintenance of buildings, public places, infrastructure and vehicles;
- standards of food safety and inspection;
- standards as to the availability and provision of medical care; and
- weather conditions.

I also understand and acknowledge that while living abroad I may encounter risks related to, for example:

- political unrest or instability, including civil unrest, violence, terrorism, crime, illness, kidnapping and other threats;
- different dietary customs;
- different educational systems and academic expectations;
- different recognition of civil rights or accommodations for persons with disabilities;
- different laws and expectations with respect to alcohol and drug use; and
- different relationship with respect to gender, sexual orientation, and gender identity issues.

By indicating my acceptance through the check-mark and initialing the Release, Waiver, and Assumption of Risk Agreement on the Field Work Term Registration Form, I willingly assume all such risks. I hereby waive any potential claims against Bennington College, its officers, and employees, releasing them from liability for any illness, injury (up to and including death), mental and emotional harm, and property damage that may occur during my participation in off-campus experiences, including living, studying, and/or working away from the Bennington campus, as well as traveling to or from any location for domestic or international Field Work Term experiences.

FOR FIELD WORK TERM EXPERIENCES WHILE LIVING ABROAD:

I understand that it is my responsibility to research the visa regulations related to the specific countries I will be visiting, to stay up-to-date on any changes to such regulations, and to ensure that I have met the required credentials and paperwork requirements before I travel. I have been informed how to locate the **U.S. State Department Travel Warnings and Consular Information Sheets**, and have read and understand the State Department's information specific to the countries I will be visiting, including any **travel advisories**. If I am not a U.S. citizen, I understand that I should also check my home country's embassy website for travel information. I have been informed how to locate the **Centers for Disease Control and Prevention Travel Health Notices** and have read and understand any travel health notices for the countries I will be visiting. I have made my own inquiries and investigation into risks and differences in those countries, and my decisions about where to travel are entirely my own. I understand and acknowledge that I am solely responsible for my own safety and welfare at all times.
