**Verify Income and Tax Confirmation – Calendar Year 2018**

DATA RETRIEVAL ON FAFSA or TAX RETURN TRANSCRIPT: If the student/spouse/parents filed a 2018 IRS Tax Return, the easiest and fastest way to verify your income is to use the IRS Data Retrieval Tool (IRS DRT) on the student’s FAFSA. If successfully transferred and not changed, an IRS Tax Return Transcript is not required. If you are unable to use the Data Retrieval Tool, or if changes are made to the FAFSA after the IRS transfer, you must obtain your 2018 IRS Tax Return Transcript online at [www.irs.gov/get-transcript](http://www.irs.gov/get-transcript) or by phone at 1-800-908-9946.
